Rental Subsidies Information

NEHP has some rental subsidies available through Manitoba Housing for tenants that are approved for tenancy. The Rent Subsidies are based on RGI (Rent Geared to Income) of 30% which means that a tenant household shall need to pay up to 30% of their gross annual income towards their rent. The remaining 70% of the rent may be covered by Manitoba Housing if your household is approved.

Example 1

If household working income is \$30,000 you would be required to pay \$9,000 towards your annual rent. If your rent was \$1000 a month you would pay \$300 to NEHP and Rental Subsidies would pay \$700.

Example 2

If your household is on EIA the formula is based on current EIA rental rates. If you are single EIA would cover \$285 a month, if you have 1 child EIA would cover \$387 a month if you have 2 or more children ELA would cover \$430 a month. The remained of the monthly rent would be covered by the rental subsidy.

Once you are approved you will be responsible to annually renew the rental subsidies

4 months prior to the expiration date. NEHP will mail a renewal package to you 4 months

prior to the expiration of your rental subsidies.
